

Minutes

The meeting was held in Four Elms Village Hall on Tuesday 11th July 2023 and commenced at 7.30 pm. The Planning Meeting commenced at 7.00 pm.

Public Forum

Cllr McArthur reported on KCC recycling projects with the IT recycling scheme being rolled out. Details are available on the Device Recycling Scheme website. On the Plan Tree Project 50 sites had been identified for the next 2 years. There is funding available for more new trees too. No Mow May had resulted in an increase in flying insects.

As a pothole update there is a new machine that fills patches rather than just the pothole which should result in improved repairs. There are two machines across the county. On the M20 Operation Brock will be in place for the summer.

Cllr McArthur had visited the new Edenbridge Hospital building and was pleased to report it seemed to be on track for completion at the end of the year.

- Apologies received and duly approved from Councillor Joanna Wade, Councillor Stephen Lark, Councillor Phil Lindsay, Councillor Duncan Leslie, Councillor Edward de Ryckman, Councillor Rick Brookes-Smith and District Councillor Barnett.
- 2) No declarations of interest were received.
- 3) The minutes of the meeting held on the 16th May 2023 were duly approved and signed.
- 4) Planning: Views agreed by the Planning Committee were ratified.
- 5) Finance
 - a) Bank reconciliation was unanimously approved and signed by member of FEC (AH).
 - b) Payment for items of expenditure, including ratification of payments made between meetings, was duly approved.
 - c) The report was received on expenditure against budget for the first quarter of 23-24.
- 6) Update reports were received on:
 - a) Pond Settlement of the insurance claim (£2,412.50) for costs incurred for repairs to damage caused at the pond by the road traffic accident in November 2022 had now been received. Solicitors on behalf of the Insurer are attempting to reclaim costs, including the £250 excess paid from the Pond Account, from the party involved.

A local resident has kindly been cutting the grass around the pond. It was proposed that a contribution should be made towards fuel costs for the equipment of £40 per year, split into two payments of £20 each. Cllr Haydon proposed and this this was seconded by Cllr Thomas and duly approved. Cllr Roberts is to provide Clerk with details for payment.

- b) Gatwick Application (Development Consent Order (DCO)) has been submitted for the Northern Runway Project to the Planning Inspectorate (PINS). Once the application is open for comment Cllr Lark will assist with a response. Cllr Barnett is also raising concerns.
- 7) No Grant Applications were received in time for consideration.
- 8) Review and adopt:
 - a) Standing Orders 2023 duly adopted.
- 9) Roads

Highways Improvement Plan – At the next submission of the HIP this is to be updated to reflect ATC results. HPC will also look at pressing for reduced speed limits past Four Elms School to the crossroads.

- a) Four Elms Crossroads Feedback has now been received from Highways on their assessment of the crossroads. Some of the markings will be refreshed to emphasise the approach to the crossroads. Signage was checked and the opinion was that further signage would not improve safety. HPC has asked that Kent Highways persist in requesting satellite navigation companies to modify systems to highlight that drivers must stop at the crossroads when approaching from Four Elms School.
- b) Traffic Speed Surveys Additional ATC surveys have been requested for Four Elms and will be carried out soon. HPC will meet the cost of these, which will total £255. The survey carried out through Markbeech showed reduced speeds. As a result, HPC will press to get the speed limit lowered.
- 10) To consider the closure of the Four Elms Playing Field Charity The Clerk has enquired regarding closing the charity associated with the field. The field is looked after and used as intended, and is in the name of HPC, it is felt there is no need to continue with the Charity. The Charity was set up back in 1978. There are no financial incomings or outgoings associated with it and to close it would ease administration. Duly approved. Clerk to pursue next steps with the Charity Commission to close it.
- 11) To consider funding swathe cuts across the Parish to allow for 3 cuts per year rather than the 1 now provided by KCC. This would be in conjunction with the Chiddingstone cluster as in prior years. Approved in principle. Clerk to investigate costs.
- 12) Co-option for Councillor Vacancy Four Elms Ward. Duly approved. Clerk to advertise vacancy.
- 13) Hever defibrillator this is currently situated at Hever School, but due to the security gate, is not instantly accessible 24/7. Edenbridge Community First Responders are willing to take over maintenance but need it to be accessible. It was suggested the Henry Pub might well be a suitable central point to relocate it to. Clerk to approach the Landlord.
- 14) To receive report from Clerk outlining any actions taken since the previous meeting and any other updates.

- a) Caretaking duties: The notice boards across the parish are scheduled to be maintained over the summer. The toddler swing seat at the Four Elms playground is to be replaced. The playground annual Safety inspection will take place shortly.
- b) Free Family Fun Day 15th August. The Four Elms School PTA are not available so the Clerk will attend and will purchase some refreshments to offer to children attending the event.
- c) Policing Update Following the Police restructure the parish has been assigned a Beat Officer, Michael Sexton. Clerk will invite him to a HPC meeting.
- d) Four Elms School is converting to an Academy and subsequently there will be a change of licence (from KCC to the Academy) to use Four Elms Playing Field. Cllr Wade has kindly agreed to review the new agreement and the Clerk will only appoint a solicitor if it is deemed necessary. Clerk has enquired as to whether any legal costs might be met by KCC or the Academy.
- e) Training Various options on offer have been circulated which are available to all Councillors, who are to let Clerk know which they would like to attend.
- f) Tribute Bench. The family concerned has ordered the tribute bench and it should be installed in Four Elms over the summer.
- g) Electric Vehicle Charging points Clerk is investigating options.
- 15) Items for information only and correspondence
 - a) Community Cost of Living Grant from KCC. Delighted to confirm the grant, applied for by HPC for Bridges Centre of £1,000, has been awarded. Clerk to arrange transfer of monies to Bridges Centre.
 - b) Bulk Refuse Freighter is due the morning of Saturday 22 July 2023.
- 16) Items for noting or inclusion on future agenda at the discretion of the Chairman.
 - a) There is some funding of up to 4k for capital projects available from the UK Prosperity Fund. Ideas invited. Clerk to investigate if monies could be used from this for public footpath refurbishment.
 - b) Affordable Housing Survey. This is due to be carried out and will be discussed at the next meeting.

We were disappointed to learn that the Ecological Survey was carried out after the land was cleared with potentially valuable natural habitat already destroyed. There are also questions over whether the land might have been contaminated in the past and of the future long-term development intentions.
