Section 137 of the Local Government Act, 1972 allows a local authority to incur expenditure which in their opinion is in the interests of, and will bring direct benefit to, their area or any part of it or all or some of its inhabitants.

Section 19(3) of the Local Government (Miscellaneous Provisions) Act 1976 gives a local council the power to make grants to voluntary organisations.

Description of project / intended	We are requesting a donation towards the running costs of our family advice service.
use for funding / date the funding is needed	The Family Service within We Are Beams are a team of experienced advisors who offer support to families of disabled children aged between 4 – 19 years. The children usually have one or more learning difficulties, complex needs, physical or sensory impairment as a result of their disability. Our service is offered in the Dartford, Sevenoaks and Gravesham areas We are the first point of contact for parents and carers who need help coping with their child's disability and behaviour. Caring for a disabled child 24/7 is challenging and can cause stress and take a toll on mental and physical health. Many families are at crisis point, suffering from exhaustion and despair. We guide and advise parents to make the best choices for their disabled child. We offer a Telephone Help-line, Home visits, Drop-in Advise Sessions, Support Groups and deliver educational Parenting Programmes. We are relatable and empathetic, we are able to put parents at ease by making them feel less nervous/anxious and more relaxed and comfortable. We offer a range of advice from education, health, financial matters to mobility and transport concerns. Families are usually referred to us by their GPs paediatrician and education professionals. Our outcomes are to improve the health and wellbeing of parents and their children, prevent a family from falling into crisis, increase confidence dealing with disability, teach new parenting skills/coping strategies and provide children with better educational outcomes. We help to build strong relationships with other families in the same position which reduces isolation.

We work together with other charities to make sure that families of disabled children in Kent get the support they need. We work beside Homestart, Little Buddies, and Demelza Hospice to provide the best possible facilities and services. We also work closely with Kent County Council to deliver commissioned services for disabled children. Our Direct Payment Service is fully commissioned, and our 6-bedded respite facility has a spot purchase agreement. We have collaborated with The Elliot Holmes Memorial Fund which provides access to mental-health & counselling for young people 13-18 living in Gravesham.

Ofsted & Care Quality Commission found that too many children/young people with SEND in Kent don't get the support they need. At least 41% of these children have a diagnosis of ASD, which is higher than the national average of 30%. Beams has recorded at least 80% of calls are about education support.

With governments funding cuts families are feeling lost, frustrated and unsupported. Kent Needs Analysis Report 2022 recorded that The Sevenoaks District has the highest percentage (5%) of under 25s with special educational needs and disabilities, physical and severe learning difficulties and social and emotional health problems. Too many young people with SEND do not get the support they need in Kent. CAMHS has a 4 year waiting list The ongoing lack of support has had a detrimental impact on disabled children's lives. If the correct level of support is not put in place by services, not only are disabled children unable to reach their potential but families are left to plug the gaps in support. This means that the whole family is restricted in their opportunities. Wider research indicates that parents and carers spend around 60 hours a week looking after their disabled child. Compared with other carers, parents of disabled children are twice as likely to care for more than 100 hours per week. As a result, less than one in four parents or carers are able to work full time. Beams has seen a significant increase in the amount of calls on education support and at least 80% of calls to the service are on this topic.

Other sources of funding considered / applied for	We are applying to other parish councils that our service users reside in, along with town councils and other grant providers.
Who will benefit from this project over what time period?	Any resident with a disabled child or young person is able to access our full offer and currently there are families within the parish that already access our family advice service. The award would support the running of this service for a year from the date of award.
How will this be demonstrated?	We will be able to demonstrate the impact this has on our families via our mid-term and long term surveys that we have in place.

Hever Parish Council annually sets a community support budget in order to provide financial assistance to a range of organisations, projects and activities which provide services for local residents.

The budget is discretionary funding and as such is separate from any other services which the Parish Council may fund under contract to fulfil statutory obligations or the delegated works of its Committees.

Hever Parish Council & The Clerk is available to anyone in the parish to assist community groups / projects in a number of ways;

- with further grant searching through local, regional and National bodies
- assistance with project planning
- A local council may also make loans to voluntary organisations in relation to running village halls (this may be a direct loan during the current year, from accumulated revenue, or unspent capital receipts).
- ➤ A local council which purchases equipment or building materials or pays for building work for a village hall, may reclaim VAT under section 33 of the VAT Act 1994, provided a number of conditions are met.
- ➤ A local council can also give practical help to the running of a local charity in many ways, for example; encouraging local people and organisations in the area to use and support activities and events
- calling a parish meeting to help organise fund raising activities
- facilitating use of parish noticeboards
- providing information and advice about other local authorities / groups
- raising the profile of the group / project

The Parish Council may wish to seek evidence against all or some of the following criteria:

- there is clear evidence of local need or demand for the proposed project/activity
- the grant will help provide a facility or service that will be of real and direct benefit to local residents
- the project/activity is properly thought through, is viable, of good quality and will ensure proper use of public funds, providing best value and value for money
- the organisation/project demonstrates clear knowledge and commitment to equal opportunities and Health & Safety.

The focus of the bulk of the grant process will primarily be for organisations/projects located within Hever, Four Elms and Markbeech Parish
