

## Hever Parish Council – Community Support Grant Application Form

Each year HPC allocates a limited amount of funding to support parish projects and assets. If you wish to apply for a grant please complete the application form below and return to the clerk at least 2 weeks before the next meeting. Please note, if funding is no longer available, your application will be considered in the next financial year

Section 137 of the Local Government Act, 1972 allows a local authority to incur expenditure which in their opinion is in the interests of, and will bring direct benefit to, their area or any part of it or all or some of its inhabitants.

Section 19(3) of the Local Government (Miscellaneous Provisions) Act 1976 gives a local council the power to make grants to voluntary organisations.

feelings. We provide this by telephone, face to face, email and webchat. We are available 24 hours a day 365 days a year. Samaritans nationally respond to a call for help every 10 seconds and last year our branch answered 26, 000 calls. Most callers report a significant reduction in distress after calling us, and for one in ten we are there only support. As our service is confidential we cannot estimate the number of Hever residents who may have contacted us or will do so in the future; however it is reasonable to assume that members of your community have and may contact us. Our branch also offers talks on mental well being to all local schools, community groups, and deliver training on site at, for eg. Railway stations and school communities should it be needed following a suicide.

Hever Parish Council annually sets a community support budget in order to provide financial assistance to a range of organisations, projects and activities which provide services for local residents.

The budget is discretionary funding and as such is separate from any other services which the Parish Council may fund under contract to fulfil statutory obligations or the delegated works of its Committees.

Hever Parish Council & The Clerk is available to anyone in the parish to assist community groups / projects in a number of ways;

- with further grant searching through local, regional and National bodies
- assistance with project planning
- ➤ A local council may also make loans to voluntary organisations in relation to running village halls (this may be a direct loan during the current year, from accumulated revenue, or unspent capital receipts).
- ➤ A local council which purchases equipment or building materials or pays for building work for a village hall, may reclaim VAT under section 33 of the VAT Act 1994, provided a number of conditions are met.
- A local council can also give practical help to the running of a local charity in many ways, for example; encouraging local people and organisations in the area to use and support activities and events
- calling a parish meeting to help organise fund raising activities
- facilitating use of parish noticeboards
- providing information and advice about other local authorities / groups
- raising the profile of the group / project

The Parish Council may wish to seek evidence against all or some of the following criteria:

• there is clear evidence of local need or demand for the proposed project/activity

- the grant will help provide a facility or service that will be of real and direct benefit to local residents
- the project/activity is properly thought through, is viable, of good quality and will ensure proper use of public funds, providing best value and value for money
- the organisation/project demonstrates clear knowledge and commitment to equal opportunities and Health & Safety.

The focus of the bulk of the grant process will primarily be for organisations/projects located within Hever, Four Elms and Markbeech Parish
